#### Section VI - Precautions for Safe Handling and Use

**Steps to Be Taken in Case Material is Released or Spilled:** Cover the contaminated surface with sawdust or similar Mix and add water if necessary to form a slurry. Scoop up slurry and wash site with water . Proper cleaning procedures are essential. Trained personnel should conduct this procedure. Untrained personnel should be removed from the spilled area.

#### Waste Disposal Method:

A leaking bottle may be placed in a plastic bag and normal disposal procedures followed. Liquid samples may be absorbed using vermiculite or sand, and disposed of in the normal way. Do not allow to contaminate waterways.
